It is crystal clear that elections for two posts reserved for Nagpur branch shall take place in SEC elections for which Shri. P K Tribhuvan has been appointed as Returning Officer.

4.You both directly writing to the officially apponted returning officer in threatening and humiliating language amounts to interference in the legal process of elections of BANAE Maharashtra state.

5.Therefore, you both as life members of BANAE are hereby advised to withdraw the letter written directly to Shri PK Tribhuvan, Returning officer is highly objectionable and the threatening language amounts to interference in legal process of the election of BANAE state body and violation of the Bombay Public Trust Act 1950.
